CUSTOMER INFORMATION ABOUT ORGANIZATIONAL SPECIALTY LICENSE PLATES

All Specialty Plates

- 1. The vehicle must be currently registered in the State of Delaware with a valid registration sticker. Plates will only be issued on cars, station wagons, SUV's, or trucks with maximum gross weight of 10,000 pounds.
- 2. Vehicle must be titled and registered in the name of the applicant. The title can be in more than one person's name, but cannot be in a corporation or business name.
- 3. Only one specialty plate per vehicle. An applicant who currently has a specialty plate and is applying for a different specialty plate, must indicate so on the application. No refunds will be authorized for canceling a specialty plate.
- 4. A fee of \$10.00 must be submitted at time of application. Payment must be by check or money order.
- 5. The specialty plate can be displayed on the front of the vehicle if the applicant wishes to display the number plate on the back of the vehicle. Customers who display their specialty plate on the back of their vehicle must keep their number tag in the vehicle.
- 6. After processing the order, the plate will be mailed to the applicant or the applicant will receive notification from DMV the plate and registration card can be picked up at their designated DMV location.(approximately 4-6 weeks)
- 7. Owners wishing to transfer the specialty plate from one vehicle to another vehicle and the new vehicle is purchased from a dealership, must inform the dealer or DMV when paperwork is processed.

Organization Plates Only

- 1. When an organization's check is used to pay the cost of multiple applications and more than ten applications have to be returned for corrections or incomplete information, all applications will be returned.
- 2. When an organization submits a large number of applications at the initial issuance of the new plates, the organization will be notified when and where the plates can be obtained. The initial order is subject to a longer waiting period based on the number of applications submitted.
- 3. If an applicant leaves the organization, it is the organization's responsibility to notify DMV, on the form provided that the applicant is no longer eligible for the specialty plate. The applicant must surrender their plate to DMV and a new registration card will be given to the applicant at no charge.
- 4. The DMV must have a current list of individuals authorized to approve the application. The organization is responsible for providing an updated list upon change of authorized approval appointees.
- 5. Once a plate has been assigned to a vehicle and the owner wishes to transfer or switch numbers with another vehicle, and/or owner, there is a \$20.00 service charge per plate. New registration cards must be issued for each vehicle. New applications must be submitted. The organization must sign all applications giving approval for the switch.
- 6. Individuals with more than one vehicle may apply for one plate, per vehicle.
